Report

At 5:05PM discussion was started about the curriculum. We discussed the FAIR testing round 1. Went over the scores and how they helped us determine who would be in the A.E.P. There will be about 13-14 students starting the A.E.P Monday the 28th. Also, discussed was the use of I-ready and Study island and how these programs help the students prepare for state testing.

Health Research was explained and how it will teach the students the proper way to research items, (Wikipedia is not a proper research site). Also, it was explained how the use of e newspaper will come into play at no cost to the school.

Business and long term planning-

We currently have 97 students at SKY Academy. The last student we received was from our "refer a student" incentive. We went over how the incentive works, if you refer a student, you get a uniform free!

Fundraising/ Community Outreach-

We are looking for ways to raise funds for our school dance. The SAC, along with one of our teachers, had the idea to "tape a teacher." Wellness/ Nutrition-

We discussed the staff being a good example for the students by eating the schools lunch every day. About 60-70% of the students eat the school lunch. We are starting a garden in the back of the school that will be part of the research class as well. Hazeltine Nursery along with another volunteer will be helping with the garden. Michelle King suggested we take the students to a farm for a field trip.

There will be a health screening on Oct 22nd for the students where we will not only be doing hearing and sight tests, but we will be getting the data for their BMI. This is where we can track their progress throughout the school year.

The members wanted to know what the expectation was for them? To help advise, vote, make suggestions, listen to the community and provide feedback, speak up about any issues or concerns, and help spread the word. Can we sit in classes? Yes, this will help with your knowledge of the
