Principals Report	Curriculum/ Assessment SKY Academy has update the grading policy and plans for the curriculum. The reason behind this change is due to our data from the FSA testing. We were rated a "C" school. Last year we only had 5 data points and this year we will have 11, which will help our school grade. We have new staff with great experience that we feel will help the students prepare for the FSA testing. Benchmark testing takes place quarterly to monitor the student's progress. Business/ Long-term Planning Enrollment is currently at 183. We lost one student to moving and gained one in the same day. At the last meeting the enrollment was 190. We have lost students due to moving out of state. There have been no families leaving due to the school grade. The new staff consist of; Two science teachers, two math teachers, one language arts teacher, one social studies teacher, one PE teacher, and one new clinic aid. This leaves us with a total of two teacher for each subject, plus a teacher aid to go between classes and help with students falling behind. There is a chance that our current PE teacher will be leaving and SKY has posted the job opening. AEP will begin September 12th. Monday, Tuesday and Wednesdays. As far as enrollment we have: 4th grade-71 Thin grade-86 8th grade-44 Fundraising/ Community Outreach Parent Orientation was August 17th and it went very well. We had a full house and we were able to sell planners and uniforms. The board did bring up that it would have been nice to have the teachers all up front so they could be seen. Mr. Weerasooriya discussed how the board can be of service to the SKY Academy. They will constantly be pushing questions to make Mr. Bailey think. They see his plan for this school and want to help him achieve these goals. Also, helping track student's (data) to help a student stay on track. The board would also like fundraising expectations.
